-- PARITY ACT UPDATE --

The Amateur Radio Parity Act of 2015-H.R.1301 in the US House of Representative and S 1685 in the US Senate-- would direct the FCC to extend its rules relating to reasonable accommodation of Amateur Service communications to private land use restrictions. HR 1301 was introduced 04 March with 12 original cosponsors from both sides of the aisle. S 1685 was introduced 25 June 25 with one cosponsor.

The Amateur Radio Parity Act would require the FCC to amend its Part 97 Amateur Service rules to apply the three-part test of the PRB-1 federal pre-emption policy to include homeowners association regulations and deed restrictions, often referred to as "covenants, conditions, and restrictions" (CC&Rs). At present, PRB-1 only applies to state and local zoning laws and ordinances. The FCC has been reluctant to extend the same legal protections to include private land-use agreements without direction from Congress.

H.R. 1301 has been referred to the House Energy and Commerce Committee. Rep Greg Walden-W7EQI chairs that panel's Communications and Technology Subcommittee, which will consider the measure. S 1685 was referred to the Senate Commerce, Science and Transportation Committee's subcommittee on Communications, Technology, Innovation and the Internet, with Florida's Senator Bill Nelson voting against the bill.

NET OPERATIONS – Fred reminded all of our 440 and 2-meter nets.

LIAISON TO QCWA – There were 37 members and spouses at the 4 November lunch at Denny's on Bee Ridge Rd., Sarasota, FL. Hans Napel offered a PP presentation of "Life Before Radio and Life After Radio."

OLD BUSINESS – TARC supported the Boy Scouts at their October 17 Jamboree on the Air.

NEW BUSINESS – Jim Shortill-KJ4NDO discussed how we can help the Boy Scouts get their Technician license. Possibly purchase study books and or a class. Girl Scouts are to be contacted also.

-- FCC FILING SYSTEM DOWN AGAIN -

Continuing problems at the Federal Candy Company. (Gee, no paper licenses and now delayed licenses. Your tax dollars at work-NOT.)

The FCC Universal Licensing System (ULS) electronic batch filing (EBF) system is down again, after working for a brief window on Wednesday, 18 November following an outage on Friday, 13 November. Some files were processed through the system on the 18th, but the FCC reported on 19 November that it was again unable to process VEC license and examination session files. The problem remains unresolved.

ARRL VEC Manager Maria Somma-AB1FM, said her office again had to alert the FCC IT staff, which is looking into the issue but did not estimate how long the system would be down. Somma said it was the third time the EBF system has gone down since late September, when the FCC said a process had stopped running on an FCC server.

The FCC doesn't have a long term fix in place yet, and it appears the same issue is recurring with greater frequency. Applicants should expect delays in exam license processing, until the FCC can get fix the problem. The FCC has apologized for the continued inconvenience this is causing the Amateur Radio community.

-- NOVEMBER SOLAR ACTIVITY --

Through 29 November the 10.7 cm Solar Flux ranged from 96 to 124, with a mean value of 110.1 (vs. 101.9 for November 2014 and 102.7 for November 2013), and the A_p index was \geq 7 on 23 days. Through 28 November, the sunspot number ranged from 29 to 95, with a mean of 62.8.

Space weather during November ranged from quiet to active with four M-class and 92 C-class flares through the 28th. Severe geomagnetic disturbances from multiple CMEs peaked the A_p to 48-56 on 3-4 November, 80 on the 7th, 56 on the 10th and 39 on 18 November.

-- DECEMBER FORECAST -

Solar activity is expected to be low with low to very low levels through 07 December. There is a chance for M0class flare activity from 08-19 December with the return of the old Region 2454.

No proton events are expected.

The greater than 2 MeV electron flux is expected to be at normal to moderate levels with high levels likely 06-13 and 22-23 December due to CH HSS influence.

Geomagnetic field activity is expected to be at unsettled to active levels 05-12 and 22-23 December with G1 (Minor) storm levels likely 06-07 December due to recurrent CH HSSs activity.

The 10.7 cm Solar Flux should range from 100 to 115 and average 109.4 during December.

-- SARASOTA COUNTY EMCOM --

In Sarasota County, the Auxiliary Communications Service (ACS), working as volunteers for emergency Management, will staff the Wetgen Communications Room at the EOC during activations and drills. The ACS call sign at the EOC is WC4EM and, when conditions warrant, controlled nets will be conducted on the following

frequencies: 145.130- (no tone), 146.520 simplex, 146.580 simplex, 146.730- (100Hz), 147.120+ (136.5Hz), 147.390 (100Hz), 443.550+ (100Hz). Also the section-wide Big Stick repeater on 145.430 (100Hz) may be a source for weather information.


