#### -- THE "LEAP SECOND" --

Did you notice that extra delay in the New Year's Eve "dropping ball"? That was due to the introduction of a "time step" at the end of December to add a "leap second" as 2006 arrives. Leap seconds are needed to keep clocks in step with Earth's rotation, which varies by several thousandths of a second per day. As 2005 transitions to 2006, Coordinated Universal Time (UTC) will be retarded by exactly one second. Thus the last minute in 2005 will be 61 seconds long. This adjustment will affect UTC and all time scales based on UTC. GPS times will not be so adjusted.

# TAMIAMI AMATEUR RADIO CLUB Minutes of the Meeting 08 December 2005

President Matt Klapp-W2EQV called the meeting to order at 7:05 PM and Charlie Covell-W4DB led the pledge of allegiance. Introductions were made all around.

**MINUTES** – Dil Kay-KB8YLK moved that the minutes of the 10 November 2005 meeting be accepted as published in the December issue of *The Communicator*, seconded by Charlie-W4DB, and passed.

**CORRESPONDENCE** – Secretary Jack Sproat-W4JS summarized the 21 November letter sent by President Klapp to the Sarasota Emergency Radio Club, requesting return of the repeater, duplexers and ancillary equipment owned by TARC and being used by SERC at the Laurel/Nokomis repeater site.

TREASURER'S REPORT — Treasurer Don Gray-WD7A reported that the 13 October starting balance was \$4891.57. Receipts were \$10.00 from the November 50/50 drawing, \$561.00 from Christmas Party reservations, \$54.00 from dues, \$128.00 from sale of surplus club items at Tampa Bay Hamfest, and \$600.00 donation from Stew Haag-W4MO for the first year's tower lease, totaling \$1353.00. Expenses were \$13.92 for newsletter postage and printing, and \$34.00 for party reservation refund, totaling \$47.92. The 08 December ending balance is \$6196.65. Peter Pesa-N4RD moved acceptance of the report, seconded by Konrad Owens-WA3RRS, and passed.

## **COMMITTEE REPORTS**

**SUNSHINE** – Matt-W2EQV reported that a card had been sent to Marty Horowitz-N4FA, following his nasal surgery.

VE TESTING – Jack-W4JS commented there should be at least two candidates at the 10 December session. He then explained that the VE team has been withholding \$2.00 from each candidate's exam fee over the past year, such that we will contribute over \$60.00 to the Venice Public Library in appreciation of use of its facilities for our exams.

REPEATER/TECHNICAL – Jack-W4JS discussed his meetings during the past month with Darrell Newell, President of Newport Offices, LLC and with Steven Roberts, Newport's legal advisor. As the anticipated use of our 501(c)(3) status to procure space at Newport's tower did not appear legally feasible, Newport has offered the TARC a lease to the tower site for \$50 per month. All TARC officers favored such an agreement, and Newport has presented a lease for our approval. In the discussion following, it was requested that the equipment list be made more generic and open to addition of supporting equip-

ment. Jon Hamlet-W4ZW moved acceptance of the lease agreement with Newport Offices, as so amended, seconded by Bob Avrutik-N1RA, and passed. The lease is scheduled to be signed 14 December.

Stew-W4MO was presented with a letter of appreciation by Matt-W2EQV, recognizing Stew's contribution of the first year's lease payment of \$600.00, for which Stew received a round of applause.

Peter-N4RD moved that \$2000 be allocated for expenses relative to installation of our W4AC Repeater at the Newport site, seconded by Jon-W4ZW, and passed.

**PACKET/GATEWAY** – Bob-N1RA reported that he has all the equipment needed for installation of this facility, and that he was going to take the computers over to the east coast for programming. When completed, the facility will operate temporarily from Bob's residence.

**CLUB PROPERTY** – Charlie-W4DB reported that the club made \$128 profit from sale of miscellaneous surplus items at the Tampa Bay Hamfest on 03 December

**PUBLICITY/MEMBERSHIP** – Don-WD7A passed around copies of the proposed TARC brochure. Peter-N4RD moved that the brochure layout be accepted and brochures printed, seconded by Charlie-W4DB, and passed.

EMERGENCY COORDINATOR – Chairman Peter Pesa-N4RD gave some background on the Venice Diocese Amateur Radio Network (DARN) and reported that Don Sullenberger of DARN will talk at a club meeting after the W4AC Repeater is operational from the new site. There is a good likelihood that DARN will provide TARC with a standby generator in the future. It was clarified that the motion passed at the November TARC meeting authorized DARN to have priority use of our W4AC Repeater during any emergency operations.

**NET OPERATIONS** –Net Manager Bob Murphy-WA1UHG was not present, but Jack-W4JS remarked that we are getting about eight, or so, check-ins for our two nets. Jack added that we need additional net control stations.

**LIAISON TO EARS** – No Englewood ARS members were present.

LIAISON TO QCWA – Jack-W4JS reported that 22 Chapter 53 members and friends attended the 06 December lunch/meeting at Denny's up in Sarasota. Stew Haag-W4MO provided a very interesting program on Software Driven Radio, which may be the favored means of communication in the future.

Solar Flux and K-index vary in accordance with NOAA 27-day forecast.

### -- DECEMBER SOLAR ACTIVITY --

During December, the Solar Flux ranged from 85 up to 106, with a mean value of 90.8 (vs. 94.6 for December 2004 and 115.1 for December 2003). The A-index was  $\leq$  10 on 21 days.

While there were days when no sunspots were visible, the general absence of geomagnetic disturbances made for good propagation during the month. DX openings into the Southern Hemisphere occurred on 10 and 12 meters late in the month.

#### -- JANUARY PROPAGATION --

During January, solar activity is expected to be at very low to low levels. No greater than 10 MeV proton events are expected.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at high levels on 29 December - 04 January.

The geomagnetic field is expected to range from quiet to minor storm levels. Unsettled to active levels are expected on 07 January due to effects from recurrent coronal hold wind streams. Otherwise, expect quiet to unsettled conditions. The Solar Flux should range from 85 to 90 during January.

It should be a toss-up between 17 and 20 meters for daylight DX propagation during January. Before local noon, 17 meters will a slight edge, with 20 meters taking the lead after noon and optimizing during the late afternoon hours. The optimum nighttime DX

band should be 40 meters, however, 80 meters should also be hot.

An overview of expected propagation during 2006 follows:

**10 and 12 Meters** – During quiet periods these bands could have fair to poor north-south openings.

15 Meters – Should be fair during the first half of the year during daylight hours. As Cycle 23 fades away at the end of 2006, DX openings will be rare.

17 Meters – Will behave much like 15 meters but with more frequent and longer openings.

**20 Meters** – Will be the main player during this year of low solar activity.

**30 Meters** – Moderate openings, especially from a few hours before sunset until a few hours after sunrise.

**40, 60, 80 and 160 Meters** – Worldwide nighttime DX on 40, coast-to-coast openings on 60, and early spring, late fall, and winter openings on 80 and 160.

The National Radio Society of India which sponsored the December 2004 Andaman Island DXpedition is arranging an international ham radio convention to be held in Port Blair, Andaman Islands in April 2006. Ham radio operation is scheduled, and foreign hams will be permitted to operate from this rare location. Propagation will be pretty dicey from here, being limited to 20-meter short path openings at 0030-0230 and 1230-1400 GMT. Updates to follow!

**CLUB HISTORIAN** – This position remains vacant, with the items being stored at the home of Jack-W4JS.

**OLD BUSINESS** – In response to a request for programs, Joh-W4ZW offered to recount his experiences working in Russia as the program for February 2006.

Don-WD7A reported that he has received reservations for 31 people at our Christmas Party.

Matt-W2EQV reported that 19 people have signed up for the charter bus to Orlando. The \$30/person cost includes the \$8 admission ticket to the hamfest.

**NEW BUSINESS** – Matt-W2EQV reminded all that 2006 dues are now due.

### -- FEDERAL PHONE CHARGES --

(The following comes from a 03 December 2005 column by Financial Adviser Malcom Berko in the Englewood Sun.)

A reader questioned the \$6.50 "FCC Charge for Network Access" on his monthly BellSouth telephone bill. Verizon makes this same charge as the "Federal subscriber line charge." Berko concluded that this charge was "the usual bureaucratic panoply of mindless government mumbo-jumbo that was sneaked on our monthly bills by phone company lobbyists who covertly enrich myriad Congressional bank accounts."

"And, by golly, that's just what it is. This monthly largess is a fee that the Federal Communications Commission allows phone companies to charge its customers to compensate themselves for part of the cost of providing local connections for long-distance calls. What a load of tommyrot. Those costs have been recovered many times over."

"The FCC does not require BellSouth to charge this fee, and not a penny of that money accrues to the FCC. In early July, I wrote Bill Nelson and Mel Martinez, both US senators from Florida, and quite nicely asked them for an explanation of this charge. Neither Bill nor Mel answered my letter."

Another fine example of your government standing up for the consumers of the nation.

#### -- INTERNET LOG SEARCH --

The Internet site <a href="http://dx.qsl.net/logs/">http://dx.qsl.net/logs/</a> is a treasure trove of QSO records from myriad DX stations as well as some Stateside special event stations. QSOs are posted from back in the '90s up until the current months.

First, find the DX station in "Select a log." This will allow you to scroll through all the stations, arranged in alphanumeric order, that have logs on this site. If you find the station you're after, enter your call in the "Callsign" block. Hit "Search log." If you're in that station's log, a page will come up, tabulating all your QSOs with that station. QSO data for rare stations have been filtered, showing only date, mode and band, otherwise the data show date, time, band and mode. QSL info is provided, as well as e-mail address, web site, etc. of the DX station.

# -- W4AC REPEATER UPDATE -

In mid-December our W4AC repeater was relocated from the Anderson electric site to its new home at the Newport Offices property in the Morris Industrial Park, Englewood. Stew Haag-W4MO supervised the installation, assisted by Peter Pesa-N4RD and Jim LaCourse-KI4MOZ as the ground crew and with David Haag-KF4VGD aloft the 200' Rohn 45 tower. We owe them significant gratitude for their efforts.

While the 146.805 machine is running, and with the EchoLink capability, the installation is not yet complete. The current antenna feed line will be replaced with 7/8" hard line, the 444.100 machine and antenna are to be installed, and there is potential for a WiFi Internet connection.

The radio horizon of these repeaters is about 22 miles, which provides coverage to North Fort Myers, the western half of Charlotte County, the southwest quarter of DeSoto County, northeast to Myakka City in Manatee County, and northwest to Longboat Key and Sarasota.

## -- SKYPE GOES MAINSTREAM --

Several of our computer-savvy members quite regularly utilize Skype, based in Luxembourg, which allows its registered users to make free computer-to-computer phone calls to each other anywhere in the world. Millions of people worldwide use it and the company was recently purchased by eBay.

Much less popular in the US than in Europe, Skype has mainly appealed here to techies and budget-conscious folks. There are two big reasons for Skype's niche status. First, most computers don't have microphones. Second, even when computers have mikes, they are clumsy when compared to conventional telephones. In addition, free Skype calls can only be made to other Skype users. To call non-members who use conventional phones, you have to sign up for a prepaid service called SkypeOut, although, at 2 cents/minute, the calls are cheap.

In early December Skype released a major new version of its phone-calling software, with added features—including video calling. It is also moving its service off the computers to a new breed of Internet-based telephone handsets.

While other companies have offered free computer-to-computer phone calls, Skype is the company most identified with free Internet phone calls. The new software, Skype 2.0 can be downloaded from Skype.com. Easy to use, this software searches for people you know to see if they are registered members.

# -- U.S. POSTAL RATE INCREASE--

A reminder that the U.S. postal rates will increase effective 08 January 2006. First Class domestic mail will go up from the current 37 cents to 39 cents for the first ounce; a 2-ounce letter will increase from the current 60 cents to 63 cents. Domestic mail post cards will increase from the current 23 cents to 24 cents

A one-ounce letter to Canada or Mexico will increase from the present 60 cents to 63 cents.

A one-ounce Airmail letter to all other countries will increase from the current 80 cents to 84 cents.

## -- HDTV MANDATORY IN 2009 --

Under the latest government measure to force HDTV on the public, broadcasters must surrender their analog TV licenses on 17 February 2009. Supposedly the federal government will realize "billions of dollars" from the sale of these analog spectrum licenses to wireless telephone and broadband providers.

While TV viewers who utilize cable or satellite sources will not be affected, there are 20.5 million US households still dependent on over the air broadcasts. The benevolent welfare-state US government doesn't want those hapless souls to lose access to the joys of TV. Therefore, the House measure includes a \$1.5 billion fund to provide each of those households with up to two coupons worth \$40 each for converter boxes to attach to their analog TV sets. (Find that, or any, welfare in the US Constitution!!) The Consumers Union isn't satisfied with that unconstitutional gift, however, claiming the government is "making your TV go black and then only paying part of the costs for some of the people to make it work again, and none of the costs for others."
