Summary of topics discussed:

- 1. **Lighthouse Christmas Lights -** Andy Durette, KB1HIP, mentioned the Amateur Radio Lighthouse Society will hold their Lighthouse Christmas Lights QSO Party from December 19, 2020 through January 3, 2021. The lighthouse is currently closed but Andy will check to see if there is access to the parking lot as you must be able to see the lighthouse to participate in the event. Plan on participating on December 19. Jack Sproat, W4JS, has prepared IOTA-compliant QSL labels for cards.
- 2. **Winter Field Day** Jim Shortill, KJ4NDO, reported that Winter Field Day will be held on January 30 and 31. He encouraged all to review the guidelines and make sure you are able to create a cabrillo file. Since we will be participating at home, please take the time to prepare your setup in advance of the event. We expect to operate in the same mode as Summer Field Day. (Note: FT8/FT4 not permitted for WFD)
- 3. **Budget Plan** Paul Nienaber, KN4BAR, confirmed that the 2021 budget plan was shared with the membership and will be requested for approval at the December club meeting.
- 4. **Public Works Tower** Jim, KJ4NDO, confirmed that Public Works will not be addressing their plans for the future use of their tower on Capri Isles until after their building renovations are done in the Spring. Jim will stay in contact with the Public Works director.
- 5. **Repeater Maintenance Committee** Chet Fennell, KG4IYS, reported that the new Echolink has some functional problems that are being addressed. The tower climber

- proposed to do the assessment and necessary repair and enhancement work in one phase. Chet and Jim will propose a lease agreement for the repeater site. The Board proposes to solicit membership for contributions for the lease payment. Chet will continue to chair the maintenance committee until the tower work is done.
